OR

Gravel road entrance for Junior Show Grounds and Pioneer Posse Grounds next to Bordertown Feed & Supply (84575 Highway 11.) Follow road through gate, until road curves to south (right) proceed past the Pioneer Posse Arena, until you see the gold buildings and you are there.
